Qualifying ribbons will be awarded to all qualifiers. Rosette ribbons awarded for 1<sup>st</sup> through 4<sup>th</sup> place in Novice through Master. New title ribbons for new titles earned.



Special *Speedy Gonzalez* *Crazy 8* award each day for the fastest dog any size with the most rats found, tunnel and climb completed

Class move ups allowed only between Saturday and Sunday.

No electronic collars, no head halters, no Flexi/retractable leashes allowed on trial grounds. Do not tie dogs or otherwise attach except to a human!

Dogs run NAKED, Handlers do not!

Any dog deemed aggressive by judge or trial committee may be excused. This subject is covered extensively in the BarnHunt rules.
